Your answers also provide a picture for me, to make an informed decision as to the temperament type that would best suit your family and circumstances. As an ethical breeder, it is my responsibility to match puppies with families that set both parties up for success. A puppy's temperament and energy levels are important factors for me to consider during this process.

The information you provide on this form is handled in the strictest of confidence in accordance with privacy legislation. If your application is unsuccessful this form and any data contained within are permanently deleted. Not saved or stored, printed nor shared.

If you do not feel comfortable answering the questions, then please DO NOT submit this application form as your application will not be considered.

The Guardian Home Program

We utilise a Guardian Home Program to enable us to grow our breeding program to improve our breeding lines in accordance with the breed standard and to further raise the profile of the Australian Cobberdog.

This ensures each of our breeding dogs have a loving environment with a guardian family and reduces the need to rehome adult dogs at the cessation of their breeding life.

By joining our program, you desire to and will act as guardian for a puppy/dog that is either a female potential breeder or proven breeder, or a male potential breeder or proven breeder ("the Dog"), subject to the terms of this Agreement.

The following explains the Guardian Home Program, including our requirements for the guardian families while the Dog is part of the breeding program. The obligations we will assume as Owner/breeder, and how the Dog will become a permanent member of your family.

Benefits of the Guardian Home Program

For Guardian Families you will receive the Breeder's "pick of the litter" with an estimated value of \$25 000 to \$40 000 AUD. The Owner/breeder will pay veterinary costs associated with health testing and reproductive testing/procedures for the Dog including DNA health testing and Pennhip scoring and reproductive expenses. The outlay/cost of the dog to the guardian family is \$

In the event that this agreement is breached, the guardian will owe to the Breeder the sum of \$25 000 AUD, payable in a lump sum within 3 months of the breach.

Pro's:

- * For the breeding Dog, the Dog gets to live with the Guardian family early in life and often from 10-12 weeks of age, it will bond with the Guardian family rather than being rehomed as an adult at the conclusion of its breeding life.
A puppy considered to be a potential breeding dog is the puppy that has displayed (temperament) or possesses (DNA etc) qualities deemed to be imperative to furthering the breed.
- * No / reduced upfront cost to acquire the puppy.
- * To be an integral part of a breeder's program that will contribute to producing the very best the breed has to offer in future generations.

- * To witness the miracle of the birth / offspring that the guardian dog will eventually produce (if all health checks are passed)

Cons

- * The puppy / dog you have been entrusted with is an advocate for the breed. Therefore, as a guardian it is expected that you raise a well-adjusted balanced, obedient and well-mannered dog. This doesn't just apply to behaviour, the appearance of your cobber is to be maintained to an acceptable level for the health, comfort and aesthetics of the dog.
- * Professional grooming costs can be high. Daily at-home grooming is labour intensive.
- * Not a "con" as this applies to any dog owner, but as the guardian of a potential breeding dog EXTRA care and attention must be given to appropriate joint health (eg excluding certain activities), exercise and diet.

Females:

- * Additional care / cleaning requirements during heat cycles.
- * Higher emphasis on responsible management of females to avoid accidental matings during heat cycles (i.e. keeping the dog at home away from intact males)
- * Frequent visits to the vet during heat cycles for hormone level testing.
- * Making the bitch available at short notice to the breeder for mating purposes.
- * Frequent communication with the breeder regarding normal development and even Moreso during the pregnancy period.
- * Being without the female for 1 week prior to her expected whelping date until the puppies are weaned / raised (potentially 9 - 10 weeks)
- * Higher Council registration fees for intact dogs.
- * Understanding that during mating / gestation/ whelping/ lactation - there are always risks involved. A bitch may need unexpected / emergency veterinary or surgical treatment. These costs are borne by the breeder and all decisions regarding such treatment are solely the breeders to make.
- * Behavioural changes during certain phases of the heat cycle and pregnancy.
- * Accepting without question and adhering to ANY requests made by the breeder pertaining to the health and management of the dog.

Males:

- * Marking - entire males are more likely to mark their territory.
- * Making the stud available to the breeder when requested.
- * Visits to the vet for semen collection / AI, TCI procedures.
- * Higher Council registration fees for intact dogs.
- * Your requirement to touch the genitals regularly for the dog to be accustomed to being handled for reproductive procedures
- * Potential for whining / escape attempts if a female in the vicinity is on heat

Male and Female

- * Added cost of providing the highest quality diet possible for the duration of the dog's breeding life (males and females).
- * Accepting that the breeder may request a home visit and accommodating the request.
- * Understanding that the reproduction process and health testing (including anaesthesia) carry risks. Whilst all due care is taken, there is always the risk of complications which may lead to permanent injury/disability or death.

Highlights

- * Knowing your bitch/dog will produce puppies who will gift others with the same love, laughter and joy that you yourself have experienced.
- * Taking pride in showcasing your dog to the wider community and being able to express your opinions to others on the breed as a whole.
- * Knowing that your dog will be instrumental in furthering the Cobberdog and its progression to pure-breed status.

Difficulties

When working with the right breeder, there shouldn't be too many on this list.

- * Accepting that the decisions regarding the dog's breeding management are not yours to make.
- * Accepting that you are a GUARDIAN for the duration of the contracted period - NOT the owner of the dog. If at any point during the contracted term the Breeder believes the dog is not being cared and provided for properly or mistreated / neglected, the breeder has the right to remove the dog from you without notice / negotiation.
- * Understanding that open communication with breeder is non-negotiable.
- * Understanding that you are obligated to make the dog available at short notice and that being difficult, controversial, combative or uncontactable or non-cooperative could see the dog removed from your care.
- * Understanding that there are very limited windows of opportunity for successful matings and therefore the breeder may make requests for access to the dog at times inconvenient to you.

SUMMARY OVERVIEW TERMS OF GUARDIANSHIP

CHARMING MEKA'S PHILOSOPHY IS, A PET IS FOR LIFE!!

The purpose of this application is to ensure that both the guardian puppy and potential new family are matched for a long and rewarding life together. Charming Meka are committed to the safety and well-being of our puppies and breeding dogs. We appreciate that all situations are different and will consider all applications equally. Submission of this application does not guarantee success, all applications are carefully reviewed and a decision is provided to the applicant as soon as practicable.

I understand that upon execution of a Guardianship Agreement, should my application be successful, I am entering into a binding agreement between myself and Charming Meka Australian Cobberdogs for becoming a Guardian for an Australian Cobberdog. I confirm that I have read this entire agreement carefully and fully understand all aspects before signing (<i>Please tick to confirm you understand</i>).	
I am over the age of 18 years	
The puppy will have been examined by Charming Meka Australian Cobberdogs' veterinarian at the age of 8 weeks. The age appropriate vaccination/s will have been administered and an RFID Microchip implanted.	
I agree to ensure the animal is not used for breeding either intentional or accidental outside of the Charming Meka Breeding Program.	
I understand and agree that I shall take all necessary precautions to avoid accidental mating of the animal prior to desexing. I agree to notify Charming Meka Cobberdogs immediately if the dog has/may have or is suspected in having participated in copulation. I further acknowledge, understand and agree that in the case of a female puppy any pregnancy will result in termination of the pregnancy. In this instance, the full cost of the termination/desexing will be at my expense.	
I understand that the puppy is registered with the Master Dog Breeders and Associates (MDBA) on the Intermediary Breeding Register and the Australian Government Personal Property and Securities Register (PPSR). It must NOT be bred either accidentally or intentionally outside of the Charming Meka Breeding Program, nor would any resulting offspring be registrable as an Australian Cobberdog. Financial penalties of up to \$50 000 apply for breaching this clause.	
I agree to maintain a comprehensive Pet Insurance Policy on the puppy/dog for the duration of the Guardianship Agreement period.	
I agree that the pet will be provided with a quality diet, fresh water, shelter, exercise, vaccinations, training and any necessary veterinary treatment. That the pet will be given a loving home and not be kept solely in the yard without interaction.	
I confirm that I have been notified of any current medical conditions as far as Charming Meka Australian Cobberdogs is aware and I understand that any veterinary issues that may arise with this pet, including illnesses or accidents resulting in emergency care or surgery and costs are my responsibility after delivery has occurred.	
I understand that in the event that I can no longer keep the animal (due to a medical injury, illness, accident, change in housing situation or any other reasonable circumstance and are rendered unable to fully care for the pet, I will notify Charming Meka Australian Cobberdogs immediately and will work with Charming Meka Australian Cobberdogs to return the puppy/dog immediately.

Initial Obligations of the Guardian Family

In order to be considered for the Guardian Home Program, we require that you:

1. Live within a 60 minute driving radius to the Owner/breeder.
2. Have physical fencing to provide a safe and secure environment for the Dog. This will also protect the Dog from any unplanned pregnancies or matings which is crucial.
3. Never leave the Dog off leash in an unsecured area.
4. Have reliable transportation and willingness to bring the Dog to us or attend veterinary appointments when required throughout the year for breeding purposes, including vet appointments specific for health testing or breeding related like ultrasounds, X-rays, progesterone testing, pre-breeding clearance etc.
5. All breeding related vet appointments and health testing will be paid for by the Owner/breeder.
6. All routine and emergency (non-breeding related) vet care is the responsibility of the Guardian Home Family.
7. Maintain the dog's vaccination status at all times.
8. Maintain a healthy diet for the Dog, of predominantly raw fresh whole foods for at least 75% of their daily needs and no more than 25% dry kibble per day.
9. Maintain open lines of communication with the Owner/breeder concerning any matter related to the Dog.
10. Provide appropriate parasite control in your area suitable for breeding dogs which covers both internal and external parasite prevention including heartworm (such as Nexgard Spectra or Bravecto Plus). Or an annual SR12 injection to prevent heartworm in addition to flea tick and worm prevention. Parasite prevention is to ceased at least 30 days prior to mating.
11. Provide regular updates on the Dog's wellbeing, physical development and training to the Owner/breeder for the duration of the Guardian Home Program (until desexed).
12. Provide ongoing maintenance of the coat, keeping the Dog well brushed and trimmed in accordance with the Cobberdog Standard (i.e. no labradoodle haircuts) until adult photos have been taken for use by the Owner/breeder.
13. Understand that the Owner/breeder may need to make decisions about your female or male and you will have to respect those decisions. Examples may include but not limited to: keeping the female for a period longer than usual, additional or emergency vet care etc. All decisions will always be for the betterment of the Dog or its offspring.

Ownership

Ownership and all rights, title and interest in the Dog and its genetic biological reproductive material shall remain with the Owner/breeder. The Guardian is advised and acknowledges that the dog is registered on the Personal Property Securities Register (PPSR) held by the Australian Government. If the Dog is a female, any puppies born from the Dog shall be the sole property of the Owner/breeder. The Guardian Family shall have no ownership interest of possession rights to any such puppy. If the Dog is a male, all semen shall be the sole property of the Owner/breeder and the Guardian Family shall have no ownership interest of possession rights to any use of the semen. The Dog shall be used as breeding stock exclusively by the Owner/breeder. After the Dog ceases to be in the breeding program, the Owner/breeder shall, by written evidence of transfer, assign and transfer ownership of the Dog to the Guardian Family after spay or neuter.

The Owner/Breeder retains all right and title for the duration of the Guardian Contract until legal ownership has been transferred by the Owner/Breeder to the Guardian.

The Guardian has no legal right to alter the dog in any way. Any alteration of the animal that prohibits its ability to reproduce is deemed a breach of this agreement and will be pursued in the legal court system including but not limited to:

- the breeding value of the dog,
- the current and future loss of earnings of the Owner/Breeder,
- compensation for the termination of the dog's genetic material,

Possession

General:

Upon execution of this Agreement, the Owner/breeder shall transfer physical possession of the dog to the Guardian Family when the pup is no younger than 10 weeks of age. The Guardian Family shall retain possession of the Dog during this Agreement, subject to its obligations to return possession of the dog for breeding purposes and shall provide for its physical care and supervision of the Dog subject to the terms and conditions of this Agreement.

Owner's Possession for Breeding

The Owner/Breeder requires access to breeding dogs for reasons including and not limited to:

1. Veterinary appointments - For general reproductive purposes and/ or to monitor pregnancy (approx. 2 appointments)
2. Breeding Females– this will start at approx. day 5 (from first day of bleeding) until there have been three successful ties (usually 5-10 days maximum).
3. Whelping – The Dog will come to us for whelping approx. 7-10 days before due date and will stay until the puppies are weaned at approx. 6-8 weeks after birth of the puppies. The process lasts between 8-10 weeks in total.
4. Breeding Males – may be on short notice for 5-7 days or until a successful mating of the intended female.
5. The Guardian family shall not transfer possession of the Dog to any persons without the prior written consent of the Owner/breeder.
6. The Owner/breeder has the right to visit the residence of the Guardian Family at least once per calendar year to discuss with the Guardian family any issues concerning the care and supervision of the Dog.
7. Females will not have more than 3 litters for the owner/breeder and will be spayed 3 months following the third litter.
8. If the Owner/breeder finds it difficult to reach the Guardian Family, is met with roadblocks, or cantankerous communication in any form (comments, text messages, emails, phone calls etc) that make the working relationship hostile, and/or the guardian family refuses to do anything the breeder requests as set forth in this Agreement, the Dog will be removed from the Guardian family – immediately with no recourse.

Guardian Family Obligations

1. Raise the dog as part of your family, the Dog should live inside with you and not be kept outdoors for any extended periods.
2. Comply with the Owner/breeders nutritional and dietary guidelines and pay all cost and expenses associated with feeding the Dog (excluding when it is home with the Owner/breeder)
3. Provide the Dog with regular exercise, training and socialisation, subject to ensuring the Dog is safe.
4. Continue to ensure the Dog is compliant, crate trained, housebroken, leash trained, does not jump, mouth or excessively bark. The Dog's / puppy's safety relies on calm and focussed behaviour.
5. Provide regular veterinary check-ups, including vaccination for age, and parasite prevention, dental health etc.
6. Provide access as per the agreement for breeding and will likely be planned for females on its second or third heat cycle depending on age and psychological maturity.
7. Provide the Owner/breeder pictures and updates every month, especially timely notification of heat cycle, (Day 1 of blood seen), for each cycle.
8. Notify the Owner/breeder of any planned vacations and change of address, phone or email.
9. That in the event the Guardian Family can no longer care for the Dog that will be returned to the Owner/breeder.
10. The Guardian Family agrees that they will not sell or give away the Dog to any third person unless it is spayed/neutered and have permission from the Owner/breeder in writing.
11. The Guardian Family agrees to take all necessary precautions to safeguard against accidental mating.
12. In order to protect the Cobberdog Breed in Development, the Guardian agrees to notify the Breeder immediately of any accidental mating or suspected mating.
13. In the case of a female Cobberdog, the Guardian Family understands and agrees that any such mating will result in termination of the pregnancy.
14. The Guardian understands and agrees, that in the case of an intentional or accidental mating that results in pregnancy, failure of the Guardian Family to immediately notify the breeder and subsequently make timely arrangements for the pregnancy to be terminated shall result in the Guardian Family owing the Breeder the sum of \$50 000 AUD payable in a lump sum. Possession of the dog shall be revoked and the dog returned to the breeder immediately.
15. Should death of the dog be as a result of negligence, cruelty, neglect, lack of veterinary care or parasitic preventable causation, the Guardian will owe to the Breeder the sum of \$50 000 AUD payable in a lump sum within 3 months from the date of death.
16. Maintain council registration in accordance with local government laws.
17. **Insurance:** The pup comes to you with **1 month** insurance coverage. After this period lapses, it is your responsibility to maintain, at your expense, a valid Pet Insurance policy for the duration of the Guardianship Agreement.
18. To incur expenses related to a necropsy or autopsy being performed on the dog to determine cause of death.
19. Provide to the Owner/Breeder details of the dog's treating veterinarian or Animal Emergency Clinic.
20. Give express permission for the Owner/Breeder to have unfettered access to the dog's veterinary records at all times.

21. Agree to the Owner/Breeder using guardian supplied photos and written updates for promotional purposes including but not limited to social media platforms.

Termination of the Agreement

This Agreement shall terminate upon the occurrence of any of the following:

1. Immediately upon transfer of ownership of the Dog to the Guardian Family by the Owner/Breeder.
2. Immediately upon Owner/breeders determination that the Guardian Family is non-compliant with the terms of this Agreement and such non-compliance poses a significant risk to the health, welfare and safety of the Dog and at which time possession of the Dog returns to the Owner/breeder.
3. Immediately upon the death of the dog from natural or accidental causes.
4. Immediately upon the Guardian Family's permanent return of the Dog to the owner/breeder for any reason.
5. At the commencement of any legal action taken by the Owner/Breeder against the Guardian for Breach of this Agreement.
6. Upon discharge of the PPSR Encumbrance registration by the Owner / Breeder.

Indemnity

The Guardian Family agrees to indemnify and hold the Owner/breeder harmless from and against all claims, liabilities, losses, costs, damages, and expenses by reason of any damage to property or injury or death of individuals allegedly caused by the Dog while in the possession of the Guardian family.
